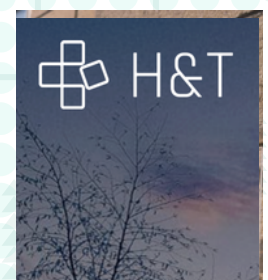
ht.digital End of Year Update - Accelerating Global Growth

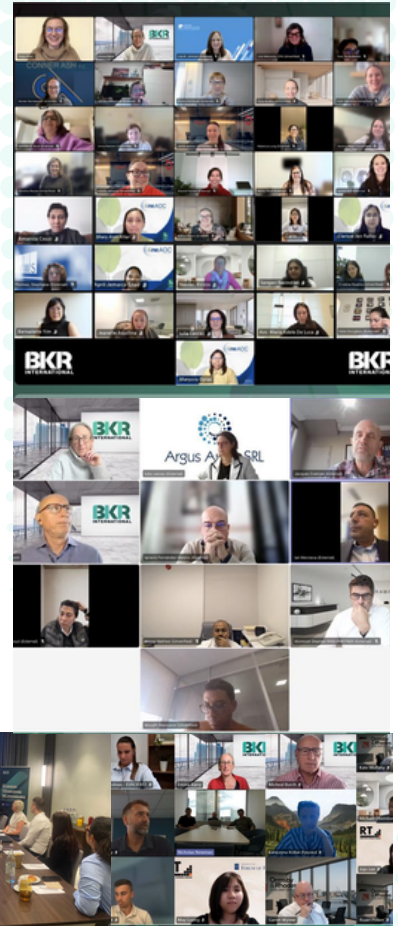
EMEA Annual Regional Conference – Dublin Highlights

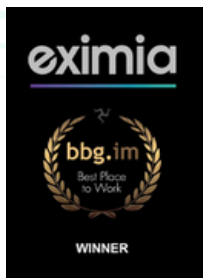
Worldwide Conference Recap – Madrid 2025
